ASES Rules and Expectations

Discipline Policy

- Step 1 = **Verbal Warning** (student is warned verbally, parent is notified, and incident is documented)
- Step 2 = **Written Warning** (student receives a written warning, parent is notified, and incident is documented)
- Step 3 = **Student suspended from program for 1-5 school days** (incident is documented)
- Step 4 = **Student suspended from program for 1-5 school days** (incident is documented)
- Step 5 = **Student removed from the program for the remainder of the session** (Session schedule: July to Dec. & Jan. to June)

-Please Note: We reserve the right to skip a disciplinary step depending on the severity of the action.

Check-Out Procedure

- Students must be signed out of the program daily
- Participating students **will** be allowed to sign themselves "in" and "out" to go home on their own, **ONLY** if parent/guardian designates this authorization on the ASES Enrollment Form
- Students must be picked-up by 6:00 p.m. daily
